

# **INDOOR RULES**

## Article 1 - GENERALITIES

People using this facily declare having read and being in agreement with the rules.

The Well being space is private and only accessible by La Maison Blanche's residents.

# **Children under 3 years of age are not permitted in the Well being space** and children under 18 must be accompanied by an aduLt who will supervise their welfare.

### Article 2 - FORBIDDEN ACCESS

Access to the building is forbidden to following people:-

- under the influence of alcohol
- abnormally agitated
- suffering with a contagious illness (circular dated 13-03-75 Ministry of Public Health).
- under the influence of drugs
- are in a state of dirtyness
- having felt unwell on the day or on previous day

#### Article 3 - HYGIENE

- Take your shoes off in the changing room and use cubicles to get changed and put your belongings in the lockers provided.

- Wear appropriate swimwear, swimming trucks are compulsory.
- Tie your hair

- Compulsory shower and use of the foot bath going in and leaving the pool area. (Especially when coming back from the beach).

- No chewing-gum
- No food or drinks indoors.
- Do not cover your body in oil or sun cream prior to using the pool
- No animals inside the building.
- Changing rooms are cleaned every day so please keep tidy when you leave.

Anyone's behaviour going against Health, Safety or security as well as cleanliness or respect of the building will be asked to leave the premises.

#### Article 4 - BEHAVIOUR IN PUBLIC

Reminder of a few community rules

- Do not damage the equipment

- Do not bring rubber-bands or inflatables from outside.

- -Do not interfere with people's clothing while they are swimming.
- No shouting
- Do not mess around in the changing rooms or around the pool.
- Do not run around the pool.

# The Well Being space is not a play area for children, the access to the Jacuzzi and the Sauna is forbidden to children.

#### Please respect the relaxation time and rest time of all users.

# Please report any information regarding any incident, damage or failures by telephone or report to reception.

#### ARTICLE 5 - AVAILABLE EQUIPMENT

Bath towels are availabe from our reception desk for 5 Euro. The towels must be returned at the end of your stay. You will be charged an extra 25 Euro if not handed back.

All equipment for the Aquagym belongs to the Residence La Maison Blanche and must remain indoors and must be looked after (i.e. Rubber rings, boards etc...). When the aquagym session is over, all equipment must be put away and for safety reasons please do not leave anything on the floor.

#### **ARTICLE 6 - RESPONSIBILITY**

Children are under parents' responsibility or the person looking after them in the building. Management declines responsibility for loss or theft in the changing rooms or around the Pool area. Any damage or deterioration in need of repair to equipment, building, i.e facades, windows etc will be dealt with by the company but costs will be charged to the person responsible for it.

#### **ARTICLE 7 - VIDEO SURVEILLANCE**

For security reasons the Well Being Space is equipped with video surveillance.
